Fact Sheet: 941 Form Fields

Overview

The 941 form is used to report tax withholding, liability and payment information to the US federal government on a quarterly basis. It is located in the Payroll module, under the Print menu. The filename of the 941 report generated in Sage Pro ERP is PRF941.frx and is created by the PRRLOG.prg program file.

The following table provides a description for each line in the 941 form, how it is calculated and which tables and fields are affected.
